CTE PROCEDURE No. 19/2021-22

Sub: Submission of Proposal for Raising of Sectional Speed by CTE.

Detailed instructions have been already been issued vide letter No. W-HQ/W-4/Track-I/ Raising of Sec. Speed/Gen./26-II dtd.15.07.2021. Copy of the same is reproduced below:-

- Many times, newly created sections of doubling/ 3rd line are opened by CRS at 75/ 90 Kmph speed with the condition to further raise the speed up to 110 kmph by CTE/WCR.
- There is a set procedure for submission of the Proposal by division to HQ. However, this speed raising proposals are not being received in correct format from some of the divisions. Therefore, once again "**Procedure for submission of proposal for raising of speed by CTE**" is reiterated.
 - Divisions to submit the Proposal (duly approved by DRM) to CBE with copy of the forwarding letter to CTE.

- If, in CRS Authorization letter, any Para is there showing "**Action plan is to be submitted to commission jointly by CAO/C & PCE**". The same should be submitted separately as per s no. 8 above.
- Generally, it is seen that division gives the TDC for some items. Therefore, division has to furnish a Certificate that "**Wherever TDC is given, in the compliance of CRS inspection note/ Authorization/ SAG & JAG inspection note, speed can be raised without any difficulty. Division has no objection to raise the further speed up to 110 Kmph.**"
