Sub: Non-collection of difference of fare from already booked passengers on account of increase in fare due to certain changes involved within the ARP period.


It has come to notice that change of originating/destination stations, upgradation of categorization of trains etc are decided and implemented at a short notice within the ARP period. This has resulted in difference of fare shown in reservation chart and also its collection by TTEs from already booked passengers.

After careful consideration, Competent Authority have now decided as under:

(i). Zonal Railways shall make all out efforts to plan in advance for any change in originating/destination/enroute stations, diversion of trains via longer route, upgradation of categorization of trains etc and the same should be implemented either with no booking date or from Advance Reservation Period (ARP).

(ii.) In case, where advance planning is not feasible due to any unavoidable reasons, no difference of fare shall be collected by TTEs from already booked passengers.

2. This issues in consultation with Coaching Directorate and also with the concurrence of Finance Directorate of Ministry of Railways.




